

Conservation Concepts, LLC Release and Waiver of Liability

PLEASE READ CAREFULLY! THIS IS A LEGAL DOCUMENT!

This Release and Waiver of Liability (the 'Release') executed on this _____ day of _____, 200____, by _____ (the 'participant'), and in effect for one full calendar year from this date, in favor of Conservation Concepts, LLC, a corporation organized and existing under the laws of the State of Washington, USA, its affiliated organizations in other nations, its directors, officers, employees, and agents (collectively, 'CC').

I, the participant, desire to engage in the activities related to being a participant on a trip to Uganda. I understand that the activities may include but are not limited to: traveling to and from other countries, traveling to and from other cities and towns, consuming food and living in accommodations available and provided in the foreign country(ies), and traveling to wilderness areas in ground transportation.

I hereby freely and voluntarily, without duress, execute this Release under the following terms:

1. Waiver and Release. I, the Participant, release and forever discharge and hold harmless CC and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from work with CC.

I understand and acknowledge that this Release discharges CC from any liability or claim that I, the Participant, may have against CC with respect to any bodily injury, personal injury, illness, death, or property damage that may result from my participation on this CC trip, whether caused by the negligence of CC, or its directors, officers, employees, or agents or otherwise. CC does not assume responsibility for or obligation to provide financial assistance or other assistance, including but no limited to medical, health, or disability insurance, in the event of injury, illness, death or property damage

2. Insurance. I, the Participant, understand that, except as otherwise agreed to by CC in writing, CC does not carry or maintain health, medical, or disability insurance coverage for any participant.

3. Medical Treatment. I hereby release and forever discharge CC from any claim whatsoever which arises or may hereafter arise on account of any first-aid, medical treatment, or other services rendered in connection with my engagement with CC.

4. Assumption of the Risk. I recognize and understand that my time with CC will include activities that are inherently hazardous, including, but not limited to, traveling on developing-world roads and visiting areas with large wildlife. I also understand that there is some inherent risk in consuming local foods and living in local accommodations available in the country(ies) visited. I further understand that I may be traveling to and from locations where there is a risk of terrorism, war, insurrection, criminal activity, inclement weather, or other circumstances that could threaten my safety or health.

I also understand that, in order to protect its employees and participants in all countries around the world, it is CC policy that it will not pay ransom or make any other payments in order to secure the release of hostages.

I hereby expressly and specifically assume the risk of injury or harm in these activities and release CC from all liability for injury, illness, death, or property damage resulting from the activities of my time with CC.

5. Security. We will take many precautions to ensure the security and safety of all CC trip participants. Security or safety may be compromised due to political instability, acts of violence or terrorism, extreme inclement weather, risks to health and other circumstances. Accordingly, CC reserves the right to cancel your trip at any point up to your departure. If CC needs to cancel the trip for safety or other reasons before the commencement of the trip, we will contact you and offer you the option of a full refund of any amounts paid to CC or the ability to reschedule to an available space on another trip. If circumstances arise during your trip that compromise safety or security, your trip may be cut short. If your trip is cancelled or cut short, CC shall not be responsible for reimbursing you for your nonrefundable expenses. If you are asked to leave the group due to an act of serious misconduct, you shall do so at your own expense. You may want to purchase trip cancellation insurance separately, which can provide a refund for other incurred expenses in the case of illness, a death in the family, or other unforeseen emergency circumstances.

6. Photographic Release. I grant and convey unto CC, all right, title, and interest in any and all photographic images and video or audio recordings made by CC during my time with CC, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

7. Other. I expressly agree that this Release is intended to be broad and inclusive as permitted by the laws of the State of Washington in the United States of America, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Washington. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provision of this Release, which shall continue to be enforceable.
